1. January 20, 2023: **Business Men from Gujarat to invest Thirty Eight Thousand Crores in UP:** During a Business-to-Government road show of UP Government in Ahmedabad, 22 investment proposals, leading to 50,000 employment opportunities were signed. UP Global Investors Summit 2023 is to be held on 10-12 February 2023 at Lucknow.

2. January 21, 2023, Surat: **Sudden Change of top Management Team at SUMUL Dairy:** Shri Mansinhbhai Kalyanjibhai Patel, Chairman Sumul Dairy, Surat terminated the services of Shri Manish Bhatt (GM-Marketing), Alpesh Shah (DGM-Operations) and Hiren Patel (Manager- Engineering) on suspicion of theft of milk.

Sumul is a Rs. 4,200 crore enterprise, with which 250,000 farmers are associated. It processes 14,00,000 litres of milk every day.

3. January 22, 2023: **Arrest Warrant for owner of the company, responsible for Morbi Bridge Collapse:** Ajanta-Oreva group had been awarded the 15-year contract for renovation, maintenance and operation of the bridge, built in 1879 by the Maharaja of Morbi.

The bridge had collapsed in the evening of 30th October 2022. 135 persons, including 34 kids had died. The Ajanta -Oreva group had opened the bridge for use by the public on 26th October 2022, the New-Year day of the Vikrami Samvat year 2079, without proper maintenance and without securing a certificate of safety from the competent authority of Morbi Municipality. *(Vikrami Samvat is the Hindu calendar, promulgated by King Vikramaditya of Ujjain, 2079 years back.)*



Morbi Suspension Bridge

Nine employees of the Ajanta-Oreva Group, the Manager and persons, responsible for day-to-day operations of the bridge, had been arrested.

The contract for maintenance of the bridge had been awarded by the Ajanta-Oreva Group to Dev Prakash Solutions. Prakash Parmar, proprietor of Dev Prakash Solutions, and his son Devang had also been arrested.

The Police had been looking for Jaysukh Patel, the promoter of Ajanta-Oreva group for questioning him. But he was evading the Police. So the Police secured an arrest warrant against him from the District Magistrate.
