The four new Trustees are:

- Padma Bhushan Rajshree Birla, the wife of the industrialist Aditya Birla, and mother of Kumarmangalam Birla: In 1995, after the death of her husband, developed Aditya Birla Centre for Community Initiatives and Rural Development, a large philanthropic organization funded by the Birla family. ABCCIR assists in the running of 42 schools and 18 hospitals and pays for the education of around 18,000 students. These activities are reported to have assisted around 7 million people in about 3000 villages in India, Thailand and Egypt.
- **Gafurbhai Bilakhia**, a *Padma* awardee, a Gandhian settled in Vapi, with creditable work in the field of trade and industry
- **Dilip Thaker**, former state information commissioner
- Harshad Patel, Vice-Chancellor of Indian Institute of Teachers Education (IITE) Gandhinagar

Eight Trustees had resigned just before the annual convocation on October 17, 2022. These were: Dr Sudarshan Iyengar, Dr Anamik Shah, Mandaben Parikh, Uttambhai Parmar, Chaitanya Bhatt, Neetaben Hardikar, Michael Mazgaonkar and Kapil Shah.

3. A 14-storey residence for Rakesh Jhunjhunwala: Rakesh Jhunjhunwala is building a 14-storey residence at the Ridge, Malabar Hill, Mumbai. The son of an Income Tax officer, Mr. Jhunjhunwala is a self-made billionaire, who is said to have a Midas-touch in the share market. The residence is for five persons: Mrs and Mr Jhunjhunwala and their two sons and a daughter. It is being built after pulling down 14 old apartments.
