India Votes, Khalistanis' role, Islamists plot murders

May 7, 2024: **Ahmedabad**, Gujarat, India: When **Narendra Modi** came out of the polling booth, he found that a big crowd had assembled, with slogans of Modi, Modi. On the day of polling, no electioneering is permitted. So, he walked towards the crowd. An old woman tied a "Raksha Bandhan" (expressing her BEST WISHES) and a young girl asked for his autograph. Then someone brought a andheld microphone to him. Modi said," Let each of us vote. In addition, please take care of your health in this hot season. Please take a lot of water."

The local newspaper 'Sandesh' carried an article titled – "Today is a Sacred Day for a Resolve to Build an India of the Future" by Dr. Ajit Sinh Rana, a popular columnist. The article said that the ten years of Modi's Prime-Ministership were a period of Empowerment, Social Justice and Inclusion. Dr. Rana said that Modi had worked for uniting people in National Interest and had worked to weaken the

forces, which try to break the society on the basis of caste or identity. He said this had strengthened democracy in India and made it more vibrant.

May 7, 2024: **Delhi**, India: An Indian court extended the pre-trial detention of opposition leader and Delhi Chief Minister Arvind Kejriwal until May 20. He was detained for money laundering and for modifying the liquor policy of the State to make money for expenditure on fighting elections in the State of Goa.

Title #5: Interference by Khalistanis: PART 2.: Khalistanis' Role through Kejriwal: May 6, 2024: Delhi, India: Delhi Lieutenant Governor VK Saxena recommended a National Investigation Agency (NIA) probe against Chief Minister and Aam Aadmi Party (AAP) Chief Arvind Kejriwal for allegedly receiving political funding from banned terror outfit 'Sikhs for Justice' (SFJ)

---- Brief BACKGROUNDER on receipt of funds by AAP from SFJ----

Ashoo Mongia, National General Secretary of **World Hindu Federation**, India, filed a complaint based on the following:

- 1. X posts by former AAP worker **Munish Kumar Raizada**.
- 2. A video in a pen drive featuring Khalistani terrorist **Gurpatwant Singh Pannun** making the allegations.

Pannun is a US citizen who is classified as a Terrorist by Government of India. He heads '**Sikhs for Justice**' (SFJ), which has been banned by Government of India under the **Unlawful Activities (Prevention) Act** (UAPA) for its anti-India terrorist activities. In March 2024, made the following claims:

- i. Kejriwal met pro-Khalistan groups at Gurdwara Richmond Hills in New York in 2014 for financial support.
- ii. From 2014 to 2022, Kejriwal and AAP got \$16 Mn from Khalistanis after Kejriwal promised support to Khalistani groups, if AAP was able to come to power.

iii. Kejriwal had promised to release **Devinder Pal Bhullar**, given the sentence of imprisonment for life for the 1993 Delhi bomb blast, which killed nine and injured 31 outside the Youth Congress headquarters. The bomb was thrown at **Bitta**, 67, the then President Youth Congress.

Bitta is Chairman of the All-India Anti-Terrorist Front (AIATF), (Bitta was injured badly. But the doctors were able to save his life.)

Earlier, in January 2024, Pannun had also alleged that both Kejriwal and Punjab chief minister **Bhagwant Mann** went back on their promise of releasing Jagdish Singh, Manjit Singh and Bhullar, Khalistanis in prison in Punjab.

Party sources of AAP had called the claims, made by Pannun, completely "baseless".

Saturday, May 4, 2024: Surat Police has arrested a 27-year-old Muslim cleric (or **Maulvi**) from Kamrez, Surat for planning to kill the leader of a Hindu organization.

"Police investigation revealed that the accused is **Mohammad Shohel** alias **Maulvi Abubakar Timol**, who worked at a thread factory as a manager and offered **private tuition on Islam to Muslim children** as a Maulvi and **teaches** in a **madrasa** (School for teaching Islam in a mosque). The accused was in contact with a 'handler' named **Dongar from Pakistan** for the last 2 years and the **Dongar** had motivated, radicalized and instigated **Abubakar Timol**," the Commissioner of Police said.

The handler from Pakistan alleged that Hindu leaders were defaming the Prophet. He said," It was the duty of every good Muslim like **Abubakar** to stop the sacrilege."

The **Donger** offered **Rs. 1 crore** (about \$120,000) 'supari' (contract for killing) and procure weapons from Pakistan to kill **Updesh Rana**, a vocal leader of Hindus in Surat.

Updesh Rana: A steadfast advocate for Hindu rights and causes, has emerged as a prominent leader in Surat, Gujarat. Updesh Rana is associated with the **Sanatan Sangh,** an NGO that works towards preserving Hindu culture, heritage, and values.

As the National Chairman of the Sanatan Sangh, Rana emphasizes the need to protect Hindu temples, traditions, and festivals. He campaigns against religious conversions and has raised concerns about the preservation of Hindu heritage sites. His speeches address issues such as love jihad, cow protection, and the need for Hindu unity.

The **Donger** and Maulvi **Abubakar Timol** discussed the murder of three other Hindu Leaders. The Hindu Leaders on their target were: **Suresh Chavhanke**, the editor-inchief and Chairman of Sudarshan television channel, **Nupur Sharma**, a former spokesperson of the **Bharatiya Janata Party** (BJP) and **Raja Singh**, a BJP MLA from Hyderabad, Telangana State.
