Lord Spencer warns: Sir Starmer is 'not a Tony Blair'; supports Sunak

May 28, 2024: **London, UK:** “*Brighter days are ahead,*” said **Rishi Sunak,**” but only if we stick to the plan to improve economic security and opportunity for everyone.” He was speaking at an Election Campaign Meeting on May 27, 2024 at London.

For the first time **after many years, inflation in UK is back to normal,** in spite of wars in Ukraine and Middle-East. **Sunak** claimed that it was proof that his government’s plan is working and that the difficult decisions, he had taken, were paying off.

Tories cut gap with Labour to 12 points and **Rishi Sunak** is firmly in the battle-field, where Tories were not supposed to be present, according to the opinion polls of the last one year.

Rishi Sunak is forthright and clear in his policies and plans.

On the other hand, Sir **Keir Starmer** is unable to decide whether he would bend under pressure from some party members for permitting **Diane Abbott** to stand in the election as a Labour candidate, when it had been decided, after an enquiry, in December 2023 not to allow her to run again due to her April 2023 comments

suggesting that Jewish, Irish, and Traveller people do not face racism “all their lives”, in a letter published in The Observer.

Rishi Sunak announced a new tax-free threshold to protect State pensioners and a rise in pensions based on ‘rise in average earning’ or ‘rise according to inflation’ or a rise by 2.5%, whichever of the three is higher.

He also announced higher defence spending and National Service for a secure future for UK.

TAXES on non-DOMICILED INDIVIDUALS: During the 2015 General Election, **Ed Miliband’s** Labour Party campaigned on abolishing non-dom status, aiming to ensure that all residents pay taxes similarly.

The concept of “non-dom” status refers to individuals who declare themselves as UK residents but maintain permanent homes abroad. This status allows them to benefit from certain tax perks, particularly related to income and gains outside the UK.

Rishi Sunak has responded by committing to increasing annual tax charges for non-domiciled individuals and addressing abuses of this status. At the Spring Budget of 2024, the Chancellor announced the abolition of the current tax regime applicable

to non-doms. Transitional arrangements were put in place to ensure a smooth transition for non-doms living in the UK to ensure fairness.

However, it has raised concerns among some wealthy individuals and their tax advisers. They are considering relocating to countries with more favorable tax regimes, such as Greece, Dubai, or Portugal.
